

Ban Pak Som School About the No Gift Policy

Ban Pak Som School approves the national reform plan for prevention and suppression of corruption and misconduct (revised version) by specifying the drive to carry out important reform activities (Big Rock), Reform Activity 5: Developing the Thai civil service system to be transparent and beneficial, with Goal 1, Section 1.1 "having every government agency declare itself to be an agency where all government officials do not accept gifts or presents of any kind in the performance of their duties (No Git Policy)" .

In this regard, to drive reform activities according to the national reform plan above, create transparency within the agency, create reputation in performing duties, and perform duties as an honest culture of Bang Sai Subdistrict Administrative Organization, it is hereby announced a policy for all executives, employees, officers, and personnel under the organization to not accept gifts and gifts of any kind from performing duties (No Gift Policy) on all festivals and special occasions, except in cases of unavoidable necessity. The criteria for accepting gifts or gifts and other benefits must be followed according to the Prime Minister's Regulations on Giving or Accepting Gifts by Government Officials B.E. 2544, together with the announcement of the National Anti-Corruption Commission on the Criteria for Accepting Property or Other Benefits by Ethical Conduct of Government Officials B.E. 2563.

Therefore, this announcement is made for general information and all executives, officers and personnel under the organization must strictly comply with the policy.

The Office of the Basic Education Commission has given importance to the administration with morality and transparency according to the policy of Prime Minister General Prayut Chan-ocha on 12 September 2014 in terms of promoting the administration of the country with good governance and preventing and suppressing corruption and misconduct in the public sector according to the Code of Ethics for Civil Servants of the Office of the Basic Education Commission 2009, the Code of Ethics for Civil Servants of the Office of the Basic Education Commission and the manual for assessing morality and transparency in the operations of government agencies (Integrity and Transparency Assessment: ITA) of the Office of the National Anti-Corruption Commission (NACC) and the Office of the Public Sector Anti-Corruption Commission (PACC).

Ban Pak Som School Has studied and administered work covering transparency, readiness, responsibility, freedom from corruption in work practices, moral culture in the organization, morality in working in the agency, and internal communication. And believes that the behavior of all civil servants and personnel under the agency must respond to the needs of society, be trusted by the people, and expect that all civil servants will behave with honor while performing their duties according to their responsibilities in order to use. Compare with practice and consider improving your own behavior to be more appropriate.

I, Mr. Wiangwiwat, would like to inform you. I would like to express my intention as the administrator of Ban Pak Som School. That we are ready to promote and support all civil servants and personnel under our supervision to work with morality and transparency in Efficient and effective operations, ready to protect the interests of the state and provide justice to the people equally and fairly.

I I would like to express my intention to all civil servants that I will perform administrative duties in Preventing and suppressing corruption in the public sector with awareness and recognizing the responsibilities that exist, will intend to perform duties with full intelligence, ability, honesty, and with mindfulness, knowing what is right and what is wrong, what should be done and what should be avoided, so that the work done is free from punishment and results in the highest benefit, adhering to the principles

Good governance in administration and will stand firm against all forms of corruption for the greatest benefit of the people by taking the following actions:

- 1. Perform every step of the work in accordance with the law, regulations and rules completely and strictly, and encourage personnel to comply with the laws, regulations and rules specified .
- 2. Instill and create awareness, values in resisting corruption, and know how to distinguish. Personal and public benefits to instill moral awareness and prevent corruption in the organization.
- 3. Do not accept corrupt behavior and do not tolerate corruption that causes social punishment, which will affect the personnel in the Kindergarten School. There is a sense of shame or fear of committing corruption .
- 4. Instill awareness in students of the school to be aware of the consequences and resist corruption.
 - 5. Guidelines for implementation and cooperation activities
- 5.1 Coordinate and cooperate in implementing the National Strategy on Prevention and Suppression of Corruption, Phase 3 (2017 2021)
- 5.2 Cooperate to join the network to prevent and suppress corruption with the Office of the Basic Education Commission, the Office of the Educational Service Area and affiliated educational institutions.
- 5.3 Participate in providing knowledge on the guidelines for promoting morality and ethics to administrators and educational personnel under the organization to participate in the dissemination of the campaign against corruption and to be a network for preventing and suppressing corruption.
- 5.4 Jointly develop communication channels, disseminate information and publicize information to support operations as a network for cooperation in preventing and suppressing corruption.
- 5.5 Provide advice , suggestions, and guidelines, including monitoring and evaluating the performance of such cooperation.
- 5.6 Participate in other actions to prevent and suppress corruption in all forms to the fullest extent of our ability.

I hereby confirm that Ban Pak Som School Will adhere to being a transparent and auditable government agency in line with the vision of the Office of the Basic Education Commission that "Basic education in Thailand has quality and international standards based on Thainess."
